


- Accurate certification, qualification and familiarization information for Conductors, Engineers, & Remote-Control Operators

- 5. Territorial Familiarization











Integrated e2e Simplified

Automated Crew Pipeline

- Qualifications + Training + Crew Management
 - Mobile OJT observations and testing can dynamically update qualifications status (FTX)
- Analytics and dashboards surface new insights, relationships and actionable intelligence
- Board sizes can be connected to other business inputs such as customer orders
 - Reduction of Guarantee & Held Away overpayments.
 - Reduction of Safety/Regulation liabilities and other enforcement actions.


What is FTX?







- Select test or rules to be evaluated
- Select a rating and enter comments
- Can select archival info by dates by Event, Time, Weather and Visibility
- Enter comments about test/event
- Incomplete data can be saved and retrieved for later
- Templates can be created for repetitive needs

Simplified Workflow

- Field evaluations and structured testing with mobile image badge capture, real-time checklists and test record uploads
- Evaluate skills required for the current working position
- Provides manager with employee's testing history with indications of past coaching/hearings on rules
- Allows setup of testing plans and goals per company and Transport Canada/FRA requirements











Field Evaluation Mobile Application

- PST carries an FTX mobile application that allows for staff to enter an event live, from a mobile device
 - ➤ This application allows for the use of the phone's camera for use in evidence gathering
 - ➤ This application is linked to the QualPro desktop instance, and is configured with all the rules and regulations loaded into the desktop instance
 - This reduces keystroke entries, and delayed delivery of ride reporting
- Compatible with IOS and Android Devices
- Can be launched within internal app store or within public app store through secured instance







QualPro Work Queue Features

Complete Recordkeeping

- Tracks employee certification and license development
- Alerts managers of action and follow-up items
- Automates and replaces manual process of running multiple reports to manage employee qualification to-do lists





QualPro Assignment Features

Reduces Manual Entry Errors

- Automates employee-to-manager relationship
- Automatically assigns the employee to the primary or secondary manager based on working position
- Balances TEY employee assignments within available managers







QualPro Licensing Features

Streamlines Certification and License Handling

- Tracks all internal and FRA requirements
- Grants ability to create license types and license requirements at-will
- Single point work-flow to certify, record, print licenses on plastic cards, and track mailing of the license.





Certification Qualification, Familiarization (CQF)

Single Point of Truth for Reports, Scheduling, Recordkeeping

- Tracks territorial qualification pursuant of FRA approved certification programs and instructions.
- Records are updated daily and displayed on dashboard
- Allows crew callers to determine if employee is qualified across all track segments of trip
- Also produces customizable reports, feedback and planning capabilities
